Dog Care Liability Waiver and Assumption of Risk Agreement

I, the undersigned, have voluntarily entered my dog into for daycare, overnight boarding, training classes, and/or grooming services (the "Services") offered by Salty Air Doggy Day Care, LLC dba Send Rover on Over. I recognize that the Services may involve strenuous physical activity for the dog or myself, including, but not limited to, running, jumping, playing with other dogs, obstacle courses, and training.

I have been advised that when dogs are around people, other dogs, food, or toys, accidents and injuries may occur. I understand that it is my sole responsibility to determine whether it is appropriate for my dog to participate in the Services taking into consideration my dog's health, temperament and other relevant factors. If I have any questions or concerns about whether my dog will get along with other dogs or whether a particular activity is appropriate for me or my dog, I understand it is solely my responsibility to make that determination.

I understand that any dog-related activity involves certain inherent risks to myself, other people, my dog and other dogs, as well as to personal property, including, but not limited to, bites, falls, sprains, cuts, bruises, broken bones, lost or broken personal property, and other serious disability or death to people or dogs. I hereby **ASSUME ALL RISKS** of these activities.

IN CONSIDERATION OF BEING ALLOWED TO PARTICIPATE IN THE SERVICES, I HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE SALTY AIR DOGGY DAY CARE, LLC DBA SEND ROVER ON OVER, ITS EMPLOYEES, OFFICERS, AGENTS AND SUCCESSORS (COLLECTIVELY, THE "RELEASED PARTIES"), FROM ANY AND ALL LIABILITY FOR ANY INJURY (TO PERSON OR DOG), WRONGFUL DEATH, LOSS OR PROPERTY DAMAGE ARISING OUT OF MY OR MY DOG'S PARTICIPATION OR ENROLLMENT IN THE SERVICES, HOWEVER CAUSED, INCLUDING BUT NOT LIMITED TO THE NEGLIGENCE OF THE RELEASED PARTIES, WHETHER PASSIVE OR ACTIVE, EXCEPT FOR THE GROSS NEGLIGENCE OR WILLFUL MISCONDUCT OF THE RELEASED PARTIES.

I also hereby agree to **INDEMNIFY, DEFEND AND HOLD** the Released Parties **HARMLESS** from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities including, but not limited to, attorney's fees, arising from, or in any way related to, my or my dog's participation in the Services, except for those arising out of the gross negligence or willful misconduct of the Released Parties.

I further agree that if any provision of this agreement is found to be unenforceable or invalid, that provision shall be severed from this agreement and the remainder of this agreement will then be construed as though the unenforceable provision had never been contained herein.

I ACKNOWLEDGE THAT I HAVE READ THIS FORM IN ITS ENTIRETY AND FULLY UNDERSTAND IT. I UNDERSTAND THAT THIS AGREEMENT CONTAINS A RELEASE OF LIABILITY. BY SIGNING THIS DOCUMENT, I UNDERSTAND I AM WAIVING CERTAIN RIGHTS I AND MY HEIRS MIGHT HAVE TO BRING A LEGAL ACTION OR ASSERT A CLAIM AGAINST SEND ROVER ON OVER INC. I AM SIGNING THIS AGREEMENT FREELY AND VOLUNTARILY.
